Guidelines and Policies for the Sue H. Morrow Memorial Scholarship
*The following guidelines have been established by the NDVC board
to assist applicants in applying for this scholarship.*

The Sue H. Morrow Memorial Scholarship provides financial aid to those NDVC Chapter members who will be furthering their education in one of the Orff-Schulwerk levels, in Las Vegas or elsewhere.

- The applicant must be a current MEMBER and ACTIVE PARTICIPANT of the local NDVC chapter of Orff-Schulwerk. Members must be regular or first year (not student members) and listed in the 2007-2008 chapter directory.
- This scholarship is NOT to be used in asking for full tuition to a level program. The purpose of this scholarship is to be used as a SUPPLEMENT. When applying, please request up to 20% of the total cost. This way, we can award money to more than one applicant. (see attached rubric for application scoring information)
- All applications must be legible to be considered (typed or black ink).
